

Memorandum of Understanding

Between

Mazandaran University of Medical Sciences

and

Republic of Zimbabwe Embassy in Iran

17 Dec 2023

Mazandaran University of Medical Sciences, Sari city, Mazandaran province of Iran, represented by its Chancellor, **Dr. Farhad Gholami** acting in accordance with the Statute, on the one hand and **Republic of Zimbabwe Embassy in Iran**, represented by its Ambassador **Mr. Bright Kupemba**, acting in accordance with the Statute, on the other hand, (hereinafter referred to as “Parties”); foreseeing the importance of collaboration for enhancing of scientific communication have signed this Agreement on Cooperation (hereinafter referred to as “Agreement”) and have agreed as follows:

1. Areas of Cooperation

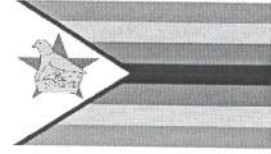
The Parties will encourage and facilitate cooperation in research and education areas based on the reciprocity and benefits for Mazandaran University of Medical Sciences and a university in Zimbabwe represented by the embassy of the Republic of Zimbabwe.

The Parties have agreed to:

- Promote organization of joint academic and scientific activities, such as courses, conferences, seminars, workshops or lectures;
- Facilitate joint research projects;
- support and facilitate mutual exchange of students, academic, research staff and Health Tourism.
- Encourage exchanging published academic and research materials;
- Facilitate publishing and implementation of the results of joint research;

2. Intercommunication

The Parties are in continual contacts to achieve the goals and objectives of the Agreement. Specific agreements will be put in place between the Parties to govern joint activities if required.

3. Final Provisions

The Agreement enters into force on the date of its signature by the Parties. The period of validity of this Agreement is 5 (five) years. On the expiry date, the Agreement will further be automatically renewed for the same period. Both Parties guarantee to each other the possibility of terminating the Agreement at 90 days written notice.

No alterations to it may be made, except by mutual consent.

The fulfillment of this Agreement does not involve any mutual financial obligations of the Parties. The Agreement has been written in two original copies in English and Persian languages; one copy for each Party.
